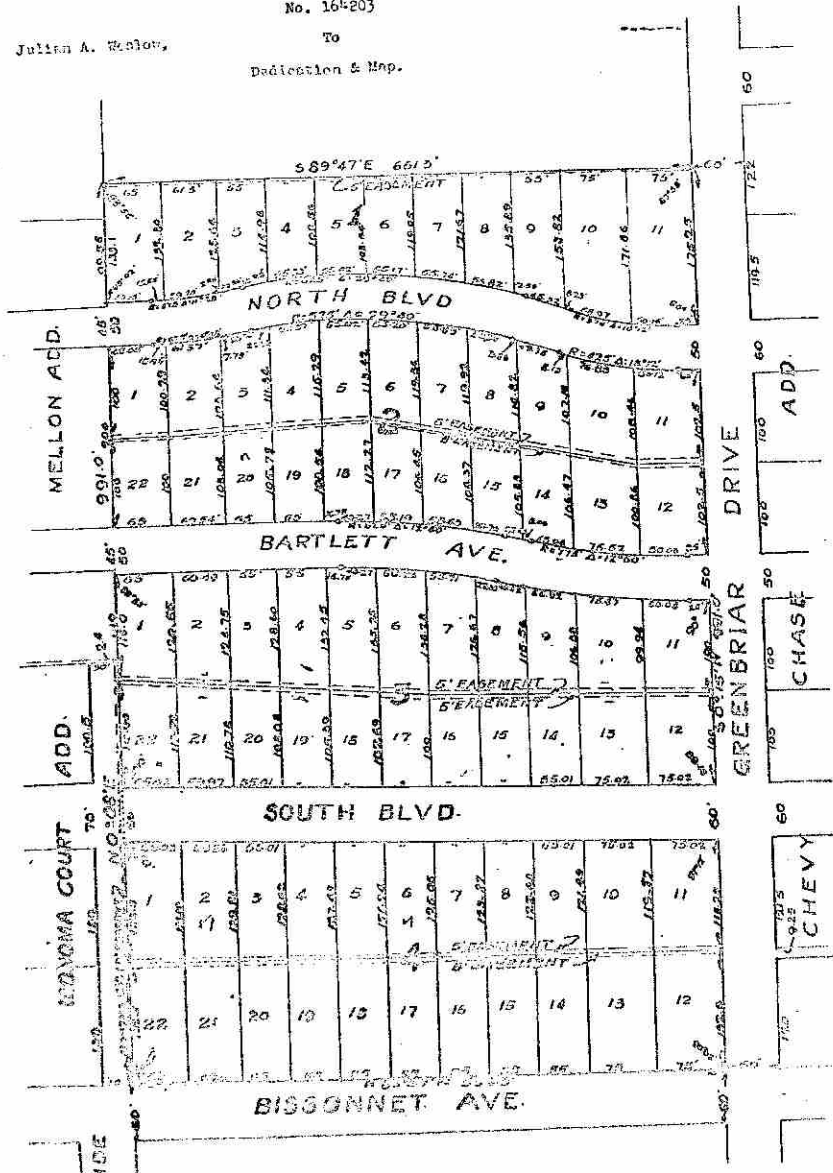

 2 property subdivided in the above and foregoing map of Greenbrier do hereby make subdivision of
 3 the said property according to the lines, lots, streets, alleys, parks, and easements, thereon
 4 shown, and designate said subdivision as Greenbrier being 14.94 acres out of the A. C. Reynolds
 5 Survey, in the City of Houston, Harris County, Texas, and dedicated to public use as such
 6 the streets, alleys, parks and easements shown thereon and do hereby waive any claim for damages
 7 sustained by the establishing of grades as approved for the streets and alleys dedicated,
 8 or occasioned by the alteration of the surface of any portion of the streets and alleys to
