On January 18, 2018, the Committee filed its Notice of Formation of the Greenbriar Addition Restrictive Covenant Petition Committee under Harris County Clerk's File No. **RP-2018-21870**. On November 26, 2018, the Committee filed the Petition to Establish Restrictive Covenants under Harris County Clerk's File No. **RP-2018-530021**. Not later than the 60th day after the date on which the Petition was filed, the Committee provided notice by certified mail, return receipt requested, to each person who owned land in the subdivision as of the date the notice was given, excluding the owners of land dedicated for public use or for use by utilities. The notice contained all requirements described in Section 201.008(a) of the Texas Property Code. The Committee also published notice as required under Section 201.008(b)(1) of the Texas Property Code by publishing said notice in the Houston Chronicle on December 1, 2018 and December 8, 2018.

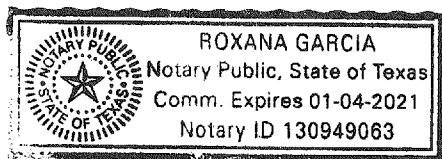

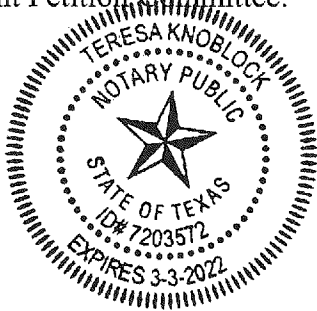

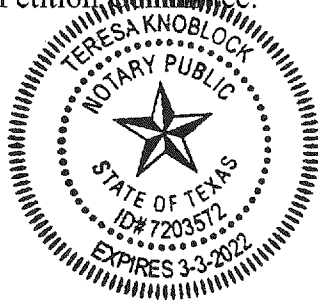
